Voter Registration

- Voters (other than above) register prior to Election Day [§ 24.2-416](#)
 - 21 days before primary or election
 - Rules for special elections also found in this section; they differ slightly depending on type of special election and timing

- Preregistration allowed [§ 24.2-403](#)

- Prior conviction eligibility – See state code for specifics:

 - Right may be restored by governor

- Voters judged mentally incompetent or under guardianship for a mental disability cannot vote [§ 24.2-101](#) (defining “Qualified voter”)

State Absentee, Early, and Mail Voting

- Early voting allowed (called In Person Absentee Voting) [§ 24.2-701.1](#)
 - NOTE: Effective beginning with the 2020 General Election
 - Beginning: 45 Days before election for voters with a valid excuse; on the second Saturday before the election for all other voters
 - Ending: Saturday immediately before the election
- No-excuse absentee voting [§ 24.2-700](#)
- Online absentee ballot application available [§ 24.2-701](#)
- Absentee ballot application is verified [§ 24.2-706](#)
- Permanent absentee voting options
 - Members of the Military [§ 24.2-703](#)
 - Absentee Ballots for One Calendar Year [§ 24.2-703.1](#)
 - NOTE: This changes to a permanent absentee voter option on July 1, 2021
- Removal from permanent absentee list [§ 24.2-703.1\(D\)](#)
 - NOTE: Only applicable beginning July 1, 2021
- Copy of Voter ID required with absentee ballot [§ 24.2-706\(B\)\(4\)](#)
 - NOTE: ID is only needed if voting for first time and ID was not provided upon registration
- Notary or witness signatures required on return envelope [§ 24.2-707](#)
- Absentee ballot verification details [§ 24.2-711.1](#)
- Someone other than the voter can return an absentee or mail ballot on behalf of the voter [§ 24.2-705](#)
 - NOTE: for emergencies only
- Deadline by which election official must receive absentee/mailed ballots [§ 24.2-709](#)
 - Before polls close on election day
- State accepts postmarked ballots that arrive after election day [§ 24.2-709\(B\)](#)
- State is required to provide secrecy sleeve for absentee/mail ballot [§ 24.2-706](#)
- Absentee/Mail ballot processing and counting procedures

 - Counting [§ 24.2-712](#)
- Absentee ballots are reported separately from precinct totals [§ 24.2-712](#)



- Spoiling/Replacement/Correction ballot restrictions
 - Only available for certain disabled or ill voters [§ 24.2-703.2](#)

In-Person Voter ID

- Photo ID requirements [§ 24.2-643\(B\)](#)
- Options for voters without ID [§ 24.2-643\(B\)](#)
 - May vote with regular ballot as long as they sign statement confirming their identity

Provisional Voting

- Provisional ballot availability [§ 24.2-653](#)
 - Voter shown as having already voted [§ 24.2-651.1](#)
 - Voter's name erroneously omitted [§ 24.2-652](#)
 - Voters who did not receive absentee ballots [§ 24.2-653.1](#)
 - Ballot cast after normal poll hours due to court-ordered extension [§ 24.2-653.2](#)
 - Voter assigned to split precinct [§ 24.2-653.3](#)
- Time allotted to determine the status of provisional ballot [§ 24.2-653.01\(A\)](#)
 - Seven calendar days after election
- Provisional ballot rejection reasons [§ 24.2-653.01\(C\)](#)
- Method for informing voters whether provisional vote was counted [§ 24.2-653.01\(C\)](#)

Polling Place

- Polling Place availability and requirements [§ 24.2-310](#)
- Electioneering or campaigning must not be closer than 40 feet to the entrance of the polling place [§ 24.2-604\(A\)](#)
- Rules governing poll observers [§ 24.2-604.5](#)
- Poll watcher qualifications [§ 24.2-604.4](#)
- National Guard permitted to step in as election officials [§ 24.2-115](#)
 - NOTE: qualifications do not prohibit National Guard members
- Curbside voting [§ 24.2-649\(A\)](#)
- Police presence [§ 24.2-607](#)
 - NOTE: this provision allows election officials to call police to make arrests at the precincts



State Emergency Rules and How Elections are Affected

- Governor has authority to set rules and procedures (after declaring “election emergency”) [§ 24.2-603.1](#)
- Listed triggers for Emergency Rules [§ 24.2-603.1](#)
 - If a state of emergency is declared by the Governor or President of the United States
- Explicit remedies in election statute [§ 24.2-604.2](#)
 - Electoral board may modify various distance prohibitions if due to unsafe area
 - Alternate election cite needed [§ 24.2-310\(D\)](#)
- All can vote by absentee ballot in state of emergency [§ 24.2-713](#)
 - Allows for some change to absentee ballot process in emergencies
 - Now that VA has no excuse absentee voting, anyone could vote absentee anytime
