

Election Statute Navigator: Rhode Island

Voter Registration

- Voter permitted to register up to and including Election Day (aka Same Day Registration) See [§ 17-1-3](#)
 - NOTE: Only available to register to vote on the same day for electors for President and Vice President; anyone registering on that day may only vote for that office and no others
- Voters (other than above) register prior to Election Day – [§ 17-1-3](#)
 - Deadlines: 30 days before election
- Online registration available– [§ 17-9.1-34](#)
- Registration via mail available – [§ 17-9.1-9](#)
- In-Person registration available
 - Department of Motor Vehicles – [§ 17-9.1-7](#)
 - Other Designated Agencies – [§ 17-9.1-8](#)
 - High Schools (once/year) – [§ 17-9.1-4.1](#)
- Automatic Voter Registration – [§ 17.9.1-7](#)
 - Participating Agencies: Department of Motor Vehicles
- Preregistration allowed – [§ 17-9.1-33](#)
 - Must be at least 16 years old to preregister
 - If 17 years old and will be 18 by next election, voter may register
- Residency requirement – [§ 17-1-3.1](#)
- Prior conviction eligibility – See state code for specifics – [§ 17-9.2-3](#)
 - Right to vote is permanently lost in cases of fraudulent voting ([§ 17-23-4](#)), bribery or intimidation of voters ([§ 17-23-5](#)), or improper influence by employers ([§ 17-23-6](#))
- Voters judged mentally incompetent or under guardianship for a mental disability cannot vote
 - See R.I. CONST. art. 2, § 1; [R.I. GEN. LAWS § 40.1-5-24.5 \(5\)](#)
 - But see [§ 40.1-5-5\(f\)\(10\)](#)

State Absentee, Early, and Mail Voting

- No-excuse absentee voting – [§ 17-20-2](#)

- RI lists excuses to vote absentee, but specifies “No specific reason necessary”
- Listed excuses to vote absentee – [§ 17-20-2](#)
- Absentee ballot application is verified – [§ 17-20-2.1](#); [§ 17-20-10](#)
- Permanent absentee voting options
 - Permanently disabled and incapacitated voters – [§ 17-20-9](#)
 - Members of the armed forces in active service – [§ 17-20-9.1](#)
 - Civilian employed by federal government outside the United States – [§ 17-20-9.3](#)
- Removal from permanent absentee list
 - See statutes for specific types of permanent absentee voters above
- Notary or witness signatures required on return envelope – [§ 17-20-21](#)
- Absentee ballot verification details – [§ 17-20-26](#)
- State allows voters to correct signature discrepancies – [§ 17-20-26](#)
- Someone other than the voter can return an absentee or mail ballot on behalf of the voter
 - See [§ 17-20-23](#) – it states that the voter must “cause” the ballot to be delivered, but does not say the voter must deliver or mail it, nor does it permit anyone else to
- Deadline by which election official must receive absentee/mailed ballots – [§ 17-20-8](#)
 - 8pm on election day
- State is required to provide secrecy sleeve for absentee/mail ballot – [§ 17-20-12](#) (envelope required)
- Absentee/Mail ballot processing and counting procedures – [§ 17-20-26](#); [§ 17-22-1](#)
- Absentee ballots are reported separately from precinct totals – [§ 17-20-26](#)
 - Counted centrally, but reported by election district
- Spoiling/Replacement/Correction ballot restrictions
 - Irregularities that may or may not spoil ballot – [§ 17-20-24](#); [§ 17-20-24.1](#); [§ 17-20-33](#)

In-Person Voter ID

- Photo ID not required – [§ 17-19-24.2](#) (ID required, but does not need to have a photo)
- Options for voters without ID – [§ 17-19-24.3](#)
 - Provisional ballot

Provisional Voting

- Provisional ballot availability – [§ 17-19-24.3](#)
- Time allotted to determine the status of provisional ballot
 - 48 Hours (per RI elections [website](#))
- Provisional ballot rejection reasons: (per this [cite](#)) (NOTE: the link they provide does not work and there is no statute stating this)
 - Voter not registered or in the wrong congressional district
 - Signature on latest voter reg. form on record does not match signature on provisional ballot application

- Signature on latest voter reg. form on record does not match signature on provisional ballot application and voter has not submitted valid ID by 4 p.m. day following election
- The individual has cast a mail ballot, emergency ballot or military ballot in the same election

Polling Place

- Polling Place availability and requirements – [§ 17-19-3.2](#); [§ 17-19-21\(A\)](#)
- Electioneering or campaigning must not be closer than 50 feet to the entrance of the polling place [410-RICR-20-00-12.6](#)
- Rules governing poll observers – [§ 17-19-21\(B\)](#); [§ 17-19-22](#); [§ 17-15-13](#) (for primaries); [§ 17-22-2](#) (during counting)
- Poll watcher qualifications – [§ 17-19-22](#)
- National Guard permitted to step in as poll workers
 - Qualifications and disqualifiers say nothing about National Guard
 - Qualifications – [§ 17-11-12](#)
 - Disqualifying Factors – [§ 17-11-15](#)
- Police presence – [§ 17-19-21\(C\)](#)
- Firearms prohibitions in election code (other state laws may apply)
 - No statutes, but administrative regulations apply (see this [website](#))
- Photography restrictions
 - You can take photos of your ballot, but not the ballots of others (see this [website](#))

State Emergency Rules and How Elections are Affected

- Governor has authority to set rules and procedures – [§ 30-15-9\(e\)](#)
- Listed triggers for Emergency Rules – [§ 30-15-9\(b\)](#)
 - Declaration of State of Emergency by Governor
- Other:
 - For personal emergencies that make a voter require a mail ballot fewer than 20 days before the election, see [§ 17-20-2.2](#); [§ 17-20-13.1](#)
